The Delhi Skill and Entrepreneurship University (DSEU) has been established through an act of the Legislative Assembly of the National Capital Territory of Delhi, namely the “Delhi Skill and Entrepreneurship University Act, 2019 (DELHI ACT 04 OF 2020) to provide quality education in applied sciences and skill education. The University came into existence on 15 August 2020 vide Notification dated 14.08.2020.

The Delhi Skill and Entrepreneurship University (DSEU) is looking for short-term appointment of Curriculum Development Experts and Subject-Matter Experts for the development of detailed syllabus and content for their courses. An organization or a team can also apply as an entity expressing interest in developing different parts of the curriculum/course development in one subject area. The broad curriculum for three years and detailed syllabus needs to be developed by June 30, 2021. The Course detail for the first 6 months/one year needs to be developed by July 31, 2021.

Key qualifications specific to relevant field of course:

1. At least Master’s Degree or equivalent in the relevant field.
2. The candidates are able to show experience in developing curriculum and imparting training in the relevant field(s) and/or a minimum of 10-15 years of work experience in the relevant field(s).
3. Recognised for their academic/industry-wide contribution to the field at national and international level.

While cost will be a consideration for this we would also look for someone who has the experience of developing curriculum and course content. Also ability to devote resources and time to the project with immediate effect will play a role in selection. The team/individual needs to

work closely with the DSEU team and be willing to receive and work on feedback.
