**EXPRESSION OF INTEREST FOR IMPLEMENTATION OF PILOT PROJECT OF UP-SKILLING OF  
CONSTRUCTION WORKERS IN N.C.R.**

The Delhi Skill and Entrepreneurship University (DSEU) has been established through an act of the Legislative Assembly of the National Capital Territory of Delhi, namely the "Delhi Skill and Entrepreneurship University Act, 2019 (DELHI ACT 04 OF 2020) to provide quality education in applied sciences and skill education. The University came into existence on 15th August 2020 vide Notification dated 14.08.2020.

Delhi Building & Other Construction Workers' Welfare (DBOCWW) Board, GNCT of Delhi, was established under Section 18(1) of the Building and Other Construction Workers (Regulation of Conditions of Service) Act, 1996, undertakes various safety, health and welfare measures for the registered building and other construction workers in NCT of Delhi.

DSEU, on behalf of the DBOCWW is planning to conduct a pilot project for upskilling of construction workers working on the currently operational construction sites in the N.C.T. of Delhi. The aim of the pilot is to gauge the efficacy of the overall program and if successful, it is to be implemented on a large scale.

DSEU is inviting organizations who have been implementing skill development schemes on a large scale in the construction sector and are willing to be a part of this pilot project. The training will include a 15-day on-the-site training program which will be implemented by Training Partners and will be followed by assessment and certification.

Training Partners/Construction companies/ Industry Bodies who fulfill the below mentioned criteria are invited to express their interest:

- Have its office in N.C.R
- Have a construction skill training division
- Have trained more than 10,000 construction workers in the past 3 years
- Training in 3 or more job roles specific to construction sector along with documentary proof
- Provide documentary evidence of its training centers and infrastructure
- Showcase its MIS platforms during the presentation

The document verification of the organization will take place after the presentation.

The following up-skilling courses are to be implemented by the organizations:

- Assistant Mason
- Assistant Bar Bender & Steel Fixer
- Assistant Shuttering Carpenter
- Assistant Electrician
- Assistant Construction Painter & Decorator

Interested applicants will make a presentation on Friday, 3<sup>rd</sup> June 2022 through a virtual platform, the details of which will be emailed to the organizations who express their interest. The presentation may not be longer than 30 minutes.

Interested organizations are requested to cover the following in their presentation:

- a) Brief background about the company.
- b) Skill development projects undertaken in the construction sector in the last 03 years including enrolled, assessed, and certified (job role wise).
- c) Training model adopted by the company in delivery of the scheme.
- d) Details of certified trainers available job role wise.
- e) Industry network or tie ups with construction companies in Delhi.
- f) Documentary evidence of training programs conducted in the past
- g) Documentary evidence of training centers developed in the past
- h) Showcase its MIS platform being used

Based on the presentation, DSEU will select a few Training Providers for the implementation of the pilot project. The decision of DSEU in this regard will be final and no representation in this regard will be entertained.
