## **ORDER**

Subject: Revised guidelines for payment of Honorarium to Visiting/Guest Faculty

- 1. It has been decided that the guidelines for payment of Honorarium to Visiting/Guest Faculty shall be revised.
- 2. The revised guidelines are as under:
- (i) The Guest Faculty to be appointed only against sanctioned post(s) and as per requirement of the teaching workload (not more than 4 Guest Faculty can be appointed/engaged against one sanctioned teaching post). However, for the Schools/Discipline where the sanctioned posts are not adequate as per the teaching working load, the number of Guest Faculty to be appointed can be up to 20% over and above the sanctioned posts as per the following norms:

S. No.	Particulars	Proposed rates per hour & maximum permissible amount per month	Remarks
1	Professors/Associate Professors Or with equivalent designation with equivalent qualification & experience etc.	Rs 2000 per hour subject to a maximum ceiling of Rs.50,000/-per month	For UG/PG Programme
2	Assistant Professors Or with equivalent designations with equivalent qualification & experience etc.	Rs 1500 per hour subject to a maximum ceiling of Rs.50,000/- per month	For UG/PG Programme
3.	For faculty not covered under 1 above, but with requisite qualification to teach Diploma level programmes/courses, students	Rs 1500/- per hour subject to a maximum ceiling of Rs 37500/- per month.	
4.	For faculty not covered under 2 above, but with requisite qualification to teach Diploma level programmes/courses, students	Rs 1000/- per hour subject to a maximum ceiling of Rs 37500/- per month.	



5.	For conduct of Lab Classes to teach UG/PG students	Rs 750/- per hour	For UG/PG Programme	
6	For conduct of Lab Classes to teach Diploma students	Rs 500/- per hour	For Diploma Programme	

- (ii) The Selection procedure for appointing Guest Faculty will be notified time to time.
- (iii) The superannuated teachers may also be considered for engagement as Guest Faculty subject to a maximum age limit of 70 years.
- (iv) Total Honorarium/Remuneration for the month should not be incurred beyond the prescribed monthly limit (including theory and practical).
- (v) The Guest/ Visiting Faculty will not be engaged for more than two campuses under DSEU at the same time."
- 3. The above revised guidelines shall be implemented with effect from the date of this Order.
